DISCUSSION

FRONT ENTRY RENOVATION PROJECT UPDATE:

The project is moving along quickly and is expected to begin within the next week. There has been a bit of a stall on behalf of the GC to find another electrical company, once a new company is obtained, Sieffert will submit final permitting application to the Village for project approval.

When the project begins, the circulation desk will move next to the temporary entrance during the renovation. Sieffert sent out a FAQ for staff to ensure everyone is on the same page and to help assist with patron questions during the project. He encouraged the staff to remain positive during patron interactions and not to commiserate any inconveniences.

The rendering will be received soon. The project is expected to be complete by the 2^{nd} week of November.

PROJECT NEXT GENERATION GRANT UPDATE:

Received \$40,000.00 grant from the Illinois State Library during the Summer. This project, which is a collaborative effort between Bensenville School District #2 and the Library, is close to implementation with the first set of classes expected to start at the end of October. The grant will focus on three different cohorts of classes, two Art-Botics sessions, and one session focused on social emotional outcomes. This grant does allow the Library to hire up to three part-time staff members for mentoring participants.

NOVEMBER TRIVIA NIGHT AT GREEN ST. GRILL AND FUNDRAISER FOR NEDFYS:

This event will be held on November 1, 2021 and will run as a fundraising event for North DuPage Family and Youth Services. Green Street will donate twenty percent of the profits back to NEDFYS. Sieffert also applied for a 50/50 raffle permit through the Village of Bensenville. This should be a very fun night for a good cause and hopefully there is a large turnout.

ROOFING PROJECT STATUS:

Engineering Solutions Team brought in Tremco to help assist with the upcoming roofing project. Received some different options and estimates that came in less than originally thought. The goal is to go to bid in early spring of 2022.

It will also inter-grate the local history collection images and documents.

ADULT SERVICES REPORT:

Adult services staff has noticed an uptick in patrons coming into the building over the last month. Reference, passport services, and the computer lab have all been busy. Sloan mentioned that as time goes on, it is good to see things settle into normalcy. Staff is busy preparing for the upcoming Winter program guide, booking presentations and developing staff-led programs.

YOUTH SERVICES REPORT:

Youth services has been very busy running Fall programming opportunities, while preparing for a busy upcoming October. Halloween is always a very popular season at the Library and this year we are bringing back the family favorite Boo-Tacular. This year's event will be registration-based families will have to reserve a block of time to attend in order to help keep things orderly and safe for everyone. This is an all-hands-on-deck affair and many staff from other departments will help to run the event. There will be different thematic stations throughout the Library.

COMMUNITY EVENTS:

Haunted Downtown – The Village of Bensenville has partnered with the popular family display to bring a more immersive Halloween experience to residents. Event will run Friday, Saturday, Sunday in downtown Bensenville through October.

Fenton Middle School night on October 1, 2021- The band will perform as well as the cheerleaders. Homecoming will be held on October 8, 202.
