

Bensenville Community Public Library Board Meeting Special Meeting Minutes September 20th, 2021

CALL TO ORDER

DISCUSSION ITEMS

REVIEW OF FRONT ENTRY PROJECT SPECIFICATIONS

Sieffert and Trustees reviewed the proposed changes to the front entry that were outlined in the project specifications developed by Engineering Solutions Team. The main goals of the project are to remove the rotted canopy and replace with a new, more open front entry. This will involve pulling the pavers and laying a new, wider concrete walkway. The lighting and bike racks will also be provided. There will also be a new knee-high seat-wall. Attention will be paid to drainage and new fascia and gutters will be install to keep the water off of the walk. The Library will keep the original door.

REVIEW OF BIDS FOR FRONT ENTRY PROJECT

At the bid opening, the Library received five bids from contractors. They ranged from the high bid of \$349,000 to the low bid from Efraim Carlson for \$197,000. After bid opening, Sieffert met with low bidder Efraim Carlson to discuss the possibility to value engineer the project to bring down the cost.

Several options were discussed, including different a finishing for the knee-high wall. Sieffert believes through value engineering, we can bring the cost of the project down another 10-15%.

REVIEW OF ENGINEER'S RECOMMENDATION

Board reviewed the recommendation from Engineering Solutions Team, which suggests that given the uncertainty of cost of labor and materials next year, it would be prudent to proceed with the project this year.
