DISCUSSION

FILLING YOUTH SERVICES VACANCY:

Sophie Welsh took another position closer to home. Have seen some good candidates in interviews. Sloan feels very good about some of the candidates and expect to find and fill the position soon.

HIRING OF YOUTH SERVICES SPANISH LANGUAGE LIBRARIAN:

This position has been filled. Rosario Zavala has a Fine Arts degree from University Illinois Chicago. She also has a background in photography. She will be able to work closely with marketing. She is currently still in graduate school.

RESTRUCTURING OF ORGANIZATIONAL CHART, RE-INTRODUCTION OF ASSISTANT DIRECTOR ROLE, MATERIAL SERVICES DEPARTMENT SUB-SECTION MANAGER POSITIONS:

Restructuring will allow a clearer delegation of duties for staff, while allowing the Director to focus on more administrative aspects of position. The Deputy Director position was a position that has always existed, but has not been filled since 2015.

Multiple employees are in new positions while still keeping the Library under the approved budget.

POSSIBLE ELECTRIC VEHICLE CHARGING STATION RESTRICTIONS:

Due to an email received by the board from a resident concerned about patterns of use of the electric vehicle charging stations installed in 2015, various options were presented to the board. The board decided to first implement a rule of "no overnight parking" in the spots, indicated by signage.

LIFTING OF STATEWIDE MASK MANDATE AND EFFECT ON LIBRARY MASK GUIDELINES:

Per the ending of the mask mandate on February 28, 2022, masks are no longer required indoors for patrons. It will be optional. Staff will remain in masks to help all patrons feel comfortable.

SPRING PROGRAM GUIDE:

The English and Spanish language Program Guides have been printed and available for patrons. The online version is also available.

This programming cycle will include virtual author visits. This will allow the Library to provide more high-profile authors for patrons.
